Personal precautions, protective equipment and emergency procedures: ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Keep unauthorized personnel away. Use personal protective equipment. Keep upwind. Ventilate closed spaces before entering them. Avoid inhalation of dust. See Section 8 of the SDS for Personal Protective Equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

Methods and material for containment and cleaning up:

Sweep up and place in a clearly labeled container for chemical waste. Avoid dust formation. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spills for later disposal.

**Notification Procedures:** 

Dike for later disposal. Prevent entry into waterways, sewer, basements or confined areas. Stop the flow of material, if this is without risk. Inform authorities if large amounts are involved.

**Environmental Precautions:** 

Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.


